HOW TO CREATE OR SUPPORT A SCHOLARSHIP AT UT

MAKE A GIFT TO SUPPORT SCHOLARSHIPS

A gift of any size, made in any way, can be designated to support scholarships. Gifts of \$50,000 and above can establish a scholarship endowment, a permanent fund that is invested, grows over time, and can generate approximately 5% of its principal for scholarships.



Support high-achieving students through scholarships

GIFT OF ANY SIZE

Establish a scholarship endowment to support students

\$50,000

payable over five years

Cover tuition for one high-achieving student per year

\$250,000

payable over five years

Provide a half-tuition scholarship

\$125,000

payable over five years

Award one student a scholarship for the full cost of attendance annually

\$550,000

payable over five years
